
Getting to know your device

LED indicator

- Solid green: The system is starting.
- Fast green blinking: The device is connecting to another Mesh device.
- Slow green blinking: Good connection
- Blinking yellow: Fair connection.
- Blinking red: Fail to connect to the internet or disconnected.




Reset button

- ① Screw holes for ceiling installation.
- ② Plastic strap holes for pole installation.
- ③ Slots for wall installation.



I. Setting up and positioning EP9

- 1 Download the **IP-COM WiFi** App onto your mobile device by searching for **IP-COM WiFi** in the App Store or Google Play or by scanning the QR code. Then, install the App. (Skip this step if you have the App.)



Available for iOS and Android



- 4 For better performance, follow the placement tips below:
 - No more than 2 walls between any two Mesh devices.
 - Place it at an open area.

- 5 Power on EP9. Observe its LED indicator until it lights one of the following colors:

Slow green blinking	Good connection
Blinking yellow	Fair connection
Blinking red	Disconnected

- 6 If the LED indicator of EP9 does not blink green slowly, relocate it according to 4 in I to get better connection.

You have completed the configuration of EP9 and found a proper position for it. Go ahead to install EP9. After installation, you can enjoy better speed performance throughout your location. EP9 shares the same SSID and WiFi password with the existing Mesh device.

Tips:

- To add a new Mesh device, the account used for setting up your existing Mesh device is required.
- The LED indicator of EP9 blinks green fast when connecting to your existing Mesh network.
- If you fail to add EP9, restore it to factory settings and try again.


II. Installing EP9

Tips: You may need a rubber hammer, a marker, a hammer drill, a drill bit, a screwdriver, and a ladder for the installation. Please prepare them yourself.


You are provided with multiple installation options, including desktop, ceiling, wall, and pole installations. Please choose the appropriate option as required. This guide provides ceiling and pole installations as examples.

■ Ceiling installation

- 1 Position the bracket on the ceiling and mark screw holes on the ceiling with your marker.




- 2 Drill holes in the marked positions using the hammer drill.




Tips: Option A applies to general situations. However, please choose option B if the strength of your ceiling material is weak, such as drywall.


- 3 Option A Use the rubber hammer to knock the expansion bolts into the holes you drilled. Then use the screwdriver to drive screws into expansion bolts so as to fasten the bracket.



- 3 Option B Use screws and expansion nuts to fasten the bracket onto the ceiling. See the following figure.




- 4 Insert the hooks of EP9 into the slots of the bracket, and rotate EP9 to lock it firmly.




■ Pole installation

- 1 Thread the two plastic straps across the holes on the bracket respectively. Attach the bracket onto the pole, and tighten the plastic straps to fix the bracket.



- 2 Insert the hooks of EP9 into the slots of the bracket, and rotate EP9 to lock it firmly.



Appendix A FAQ

Q1: The LED indicator of the EP9 blinks red. What should I do?

A1: Try the following solutions:

- Ensure that the LED indicator of your existing Mesh device blinks green.
- Move EP9 closer to your existing Mesh device until its LED indicator blinks green slowly.

Q2: How can I remove a Mesh device from my WiFi network?

A2: Run the **IP-COM WiFi** App, tap the Mesh device you want to remove, tap "...", in the upper-right corner, and choose **Delete**.
Note: This removing operation restores the Mesh device to factory settings.

Q3: How to restore EP9 to the factory settings?

A3: With all the EP9 powered on, hold the Reset button down using a paper clip for about 8 seconds. Release it when the LED indicator lights solid on. EP9 restarts automatically after being reset.

Q4: How to authorize another person to manage my WiFi network?

A4: Run the **IP-COM WiFi** App, tap **Settings**, **Account Authorization**, and **Add an account**. Enter an account registered on the **IP-COM WiFi** App, and tap **OK**.
